date hereof, until each and every sum in the said Association shall reach the value of ONE HUNDRED DOLLARS, and also for *Ten Percent*

attorney's fees, in case of suit or of collection by or through

an attorney, which, in addition to said debt, is hereby secured and made upon the premises, as in and by the said Bond and Condition thereof, reference being
thereunto had, will more fully appear.NOW, KNOW ALL MEN, That I, the said *E. Alice J. McKinney*,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE

DOLLARS, to *Mr. W. K. Morris*, the said *E. Alice J. McKinney*,

in hand, well and truly paid by the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,

I, the said *E. Alice J. McKinney*,

have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County in the City of Greer, on the

Yolick corner of *Maudie* Street.

Beginning at a point on *Maudie* Street, corner of lot #19 and *Yolick* Street, thence N 12° 53' W 142.5 feet to a stake in a 23.5' thick wall said wall N. 16° 13' E 60 feet to said stake, corner of lot #2. Thence S. 12° 58' E 142.5 feet to a stake, on side of *Maudie* Street; thence with said street 76.0' W 60 feet to the beginning corner and designated as lot #3 on a plan made by E. E. Willis of Spartanburg, S. C. and being the same tract of land conveyed by E. J. Burchell to R. H. Hudson in a deed dated August 3, 1910. It is agreed by parties hereto that as a part of the agreement hereon, this property is not to be conveyed to any person or persons or rented to any persons of African descent.
