SEND GREETING:

WHEREAS, John Davis and Claude Davis,

in and by John Davis certain promissory note in writing, of even date with these presents, indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full sum of \$1,000.00, well and truly paid on or before the date when the 10th day of October, 1929, Series of the Installments.

Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if John Davis

fail to pay said interest or to comply in all respects with the By-Laws of said association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear

NOW, KNOW ALL MEN, That John Davis the said,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to the said John Davis,

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that certain tract of land, in the ~~Recorded~~ ownership of John Davis, in Greenville County, State of South Carolina, near the City of Greenville on Taylor Avenue, and designated as lot No. 20-23, according to the plan of the Particulars of Survey of the property, made by C. C. Dalton, Engineer, and containing the following boundaries and dimensions according to Plat Book A, beginning at an iron pin on Taylor Avenue, corner of lot No. 23, at a point 196 feet from the previous corner, and running thence with the lines of lot No. 23, 15-31-36, 89 feet to iron pin; thence west line of lot no. 23 15-30 ft. 89 feet to iron pin; and Taylor Avenue, thence with said avenue N. 16-49 E. 46 feet to the original corner, being the same surveyed to record by the Surveyor of Greenville City and dated June 21, 1923, and recorded in the Register of Deeds.
