WHEREAS,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *J. Jones*, the said

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION

All that piece parcel ~~and lots~~ of land in Greenville Township, Greenville County, State of South Carolina in the city of Greenville, on Hampton Avenue, formerly West Street and Taylor, the following metes and bounds etc - wit;

Beginning at a stake on Hampton Avenue and running thence with said street or Avenue, S. 42 $\frac{1}{2}$ E. 50 feet to a stake, thence S. 57 W. 144 feet to a stake, thence N. 42 $\frac{1}{2}$ W. 50 feet to a stake, thence N. 57 E. 144 feet to the beginning corner. Being the same lot of land conveyed to me by W. B. Jones by deed dated Nov. 17, 1922 and recorded in the R. M. C. Office for Greenville County on vol. 78, page 415.
