with interest thereon, from date (November 10th, 1922) at the rate of 8 per cent. per annum to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, with more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said W.M. Wheeler, Sr. all that certain piece or parcel of land  
containing one-half acre more or less, lying and being in the County of Greenville and  
State aforesaid in Greenville Township about two and three quarter miles West of the City  
of Greenville, on the North side of Farris Bridge Road and having the following metes and  
bounds to-wit:

Beginning at a stake on the north side of Farris Bridge Road and running thence N. 9-3/4  
E. 210 feet to a stake; thence S. 80-1/2 W. 105 feet to a stake; thence S. 9-3/4 W. 210 feet  
to a stake on north side of Farris Bridge Road; thence along north side of said road N. 80-1/4  
E. 105 feet to the beginning corner, and being all of the same lot purchased from S.C.-  
Pinson, on May 31st, 1907 and recorded in R.M.C. in Greenville Co. Vol. VVV, page 259.
