line; thence S. 11 W. 174 feet to a stake on Spring Street; thence N. 84 W. 65  
feet along Spring Street to W.A. Payne's corner; thence N. 17-1/2 E. 155 feet to  
the beginning corner and being the same lot of land deed to me by John Ratterree by
