West Greenville, on the Northwest side of Endel Street and described as follows:
Lot No. 17 and the North-half of lot No. 18 as shown on Plat of Willimon property, which
plat is recorded in Plat Book "A", at page 85 and which property is more fully described
in deed from Margaret Lewis and John Lewis to E.M. Gillespie.
It is understood and agreed that this mortgage is junior to one for eight hundred seventy
and no/100 dollars given to E.W. Brown on April 18th, 1923.
