three miles southwest of Greenville County
Court House, and having the following
miles and bounds to-wit: Beginning at a
stake in the center of the White Horse
Road and a public road; thence along
the center of White Horse Road N. 6-15 W.
202 feet to a stake; thence S. 81-20 W.
crossing a branch and following same
200 feet to a point in branch; thence
continuing with said branch as follows:
S. 89-10 W. 100 feet to a bend; S. 79-0 W. 71.8
feet to a bend S. 22-15 W. 55.3 feet to a
point in the center of a bridge on a
public road; thence with line of W. T.
Looper property S. 3-16 E. 151.8 feet to a stake
in the center of an old road; thence
