NOW, KNOW ALL MEN, That we the said Bessie Logan; and William Logan, Elizabeth Logan and Minerva Logan in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of Three Dollars to us in hand way and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bessie Logan as Guardian for William Logan, Elizabeth Logan and Minerva Logan and Wm. Goldsmith, General Agent, Greenville all that piece, parcel, tract or lot of land situated in

Township, Greenville County, State of South Carolina, in the city of Greenville, on

corner of Greene Avenue and Nichols Street, beginning at point upon corner of Green Avenue and Nichols Street and running thence with Nichols Street 95.5 feet to corner lot now or formerly of Edward Anderson; thence with Anderson's line approximately 110 feet; thence in a line parallel with Nichols Street approximately 121 feet to beginning.
