according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *Date*, the said *J. D. Mae*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said *J. D. Mae his heirs and assigns*,

All that certain lot or parcel of land, situate lying and being in the state and County aforesaid near Paris Station on the Northern side of the National Highway, and being known and designated as lot no 11-X in Block "B" of the Paris subdivision of the Realty Corporation, as shown on a plat made by R. E. Dalton, Engineer, July and August 1917 and having according to said plat, the following metes and bounds to wit; Beginning at an iron pin on the northern side of the National Highway joint corner of lots nos. 10 and 11-X in Block "B" and running thence with the joint line of said lots N. 36-43 W. 177.8 feet to an iron pin; thence with line of lot no. 18 E. 61-44 W. 20 feet to an iron pin, corner of lot no. 10-X in Block "B", thence with line of said lot E. 180.7 feet to an iron pin on the Natl. highway; thence with said highway N. 53-40 E. 25 ft. to the point of beginning, being the same lot conveyed to me by the Realty Corp. July 3rd 1923, and recorded in R. M. C. office for Greenville County in deed Book 42 at page 92. Also all that other certain parcel or tract of land situate lying and being in the County and State aforesaid, at or near Paris Station and being better known and designated as lots nos. 19, 43, 44 and a 10-foot strip of the southern side of lot no. 42 of the property of W. D. Parrish, as shown on a plat of record in the R. M. C. Office for Greenville County in plat Book "E" at page 52 and having according to said plat the following metes and bounds, to wit; Beginning at an iron pin on the National Highway joint corner of lots nos. 18 and 19 and running thence with line of lot no. 18 N. 36-43 W. 80 feet to an iron pin; thence with the rear lines of nos. 19 and 18 N. 53-40 E. fifty feet to an iron pin on Spring Street, joint corner of lots nos. 19 and 44; thence with Spring Street N. 36-43 W. fifty feet to an iron pin in center of lot no. 42; thence E. 53-40 W. 75 feet to an iron pin; thence E. 36-43 E. 130 feet to the point of beginning and being the same lot conveyed to me by W. D. Parrish for Greenville County in their deed dated June 22nd 1923 and recorded in R. M. C. Office for Greenville County in deed Book 130 at page 28. There is situated on said above lots a store building and a four-room dwelling house.
