grant, bargain, sell and release unto the said The Peoples National Bank of Greenville, S.C.

All of those two lots situate, lying and being in the
County and State aforesaid, as follows:

Lot designated as No. 10 on the plat of lands of West
End Land and Improvement Company recorded in
the office of R. M. C. for said County, fronting fifty feet
on Chicora Avenue, and having the following metes
and bounds, to wit: Beginning at an iron pin on Chi-
cora Avenue joint corner of Lots Nos 10 and 9 and run-
ning thence with Chicora Avenue fifty feet in a northerly
direction; thence with line of Lot No. 11 S. 79 W. 150 feet
to an iron pin corner Lots Nos. 10 and 11, on an alley,
thence with said alley S. 11 E. 50 feet to a stake, corner
of Lots 9 and 10, thence N. 79 E. 150 feet to the beginning
corner. Being the same lot conveyed to me by the said

street S. 26-31 E. 193.4 feet to an iron pin corner of Lot No. 14;
thence with line of lot No. 14 N. 62-27 E. 60 feet to a pin in line
of lot now owned by Mrs Fannie C. Simpson; thence N. 26-31 W.
193 feet, more or less, to the beginning corner, and being the
