WHEREAS, *O. M. Owen*, the said *O. M. Owen*
in and by *my* certain note or obligation, bearing date the *1st* day of *April* 192*4*
O. M. Owen indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,

sum of *Fifteen + 33/100* (*15.33*) Dollars, (*10.00*) Dollars, being the regular monthly payment on said stock and *Five + 33/100* (*5.33*) Dollars, (*10.00*) Dollars, being the monthly interest on balance due);
for the next twenty months the sum of *Fourteen + 67/100* (*14.67*) Dollars, (*10.00*) Dollars, being the regular monthly payment on said stock and *Four + 29/100* (*4.29*)
Dollars, (*10.00*) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Twelve + 67/100* (*12.67*)
Dollars, (*10.00*) Dollars, being the regular monthly payment on said stock and *Two + 67/100* (*2.67*) Dollars, (*10.00*) Dollars, being the monthly interest on balance due); for the next twenty months pay the
