TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, D. W. Moore,
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said D. W. Moore,
in and by my certain note or obligation, bearing date the 18th day of April 1924

am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate,
duly incorporated under the laws of such State), in the sum of nine hundred & 20/100 (\$900.00) Dollars,

with interest thereon at the rate of eight per centum per annum payable monthly, from the 18th day of April A. D. 1924,
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said D. W. Moore shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April
1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

fifteen & 20/100 (\$15.00) Dollars, (\$9.00) Dollars,
being the regular monthly installment payable on the nine (9) Shares of Stock, and two & 20/100 (\$2.00) Dollars,

Dollars, being the monthly interest on the advance (loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the
sum of thirteen & 80/100 (\$13.80) Dollars, (\$9.00) Dollars,

Dollars, being the regular monthly payment on said stock and four & 80/100 (\$4.80) Dollars, being the monthly interest on balance due);
for the next twenty months the sum of ten & 20/100 (\$10.20) Dollars, being the regular monthly payment on said stock and three & 60/100 (\$3.60) Dollars,

Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of eleven & 40/100 (\$11.40)
Dollars, (\$9.00) Dollars, being the monthly payment on said shares of stock and

two & 40/100 (\$2.40) Dollars, being the monthly payment on said shares of stock and
sum of ten & 20/100 (\$10.20) Dollars, (\$9.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the

Each of the above payments to be made on the 20th or before the last day of each month, and shall hereafter surrender to the Company the said nine (9)

NOW, KNOW ALL MEN, That I the said D. W. Moore,
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is
hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and
Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

And in the City of Greenville, situate on Markley Street, known and designated as Lots
Nos. 43, 44 and 45, as shown on plat made by W.D. Neves, July 1916, and recorded in R.M.C.
Office for Greenville County in Plat Book F, page 55. Lots 44 and 45 fronting on Markley
Street and lot 43 situate directly in rear of lots 44 and 45, and having such metes and
boundaries and situate as appears by said plat except that said lots adjoin and are bounded on
the North by lots 48 and 46 instead of a fifteen-foot (15) alley as shown on said plat,
said alley having been moved and laid off along the Northern side of lots 47 and 48, and
being the same lots conveyed to me by Anthony Insurance Agency, Inc., by deed dated April
16th, 1924, to be recorded.
