

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN;

I, Nellie McMillan of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Nellie McMillan in and by my certain note or obligation, bearing date the 19th day of June 1924 am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Seven Hundred Fifty + 20/100 (\$750.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 19th day of June A. D. 1924 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Nellie McMillan shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twelve + 50/100 (\$12.50) Dollars, being the regular monthly installment payable on the Seven Hundred Fifty + 20/100 (\$750.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Eleven + 50/100 (\$11.50) Dollars, being the the regular monthly payment on said stock and Five + 10/100 (\$5.00) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Ten + 50/100 (\$10.50) Dollars, being the regular monthly payment on said stock and Three + 20/100 (\$3.00) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Nine + 50/100 (\$9.50) Dollars, being the monthly payment on said shares of stock and Eight + 50/100 (\$8.50) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eight + 50/100 (\$8.50) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 7 1/2 shares of stock and the certificate thereof for the amount of such paid shares by I to be credited as a payment upon the advance or loan made. I the said Nellie McMillan and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against I the said Nellie McMillan in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition hereunder written, reference being thereunto had will more fully appear.

NOW KNOW ALL MEN, That I the said Nellie McMillan in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Nellie McMillan in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, being lot 510.107 according to a plat recorded in Plat Book "R", page 177, R.M.C. Office for Greenville County. Said lot has a frontage of fifty (50) feet on Bridge Avenue and a depth of one hundred fifty (150) feet and is the same lot conveyed to me by G. F. Williams by his deed dated June 7th 1923, and recorded in Volume 82, page 126, R.M.C. Office for Greenville County.
