TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I Marie Williams  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I Marie Williams  
in and by my certain note or obligation, bearing date the 25 day of July 1924

am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Seven Hundred and 7/100 (\$700.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 25th day of July A. D. 1924,

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Marie Williams shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of July 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of

Sixteen and 67/100 (\$11.67) Dollars, (\$7.00) Dollars, being the regular monthly installment payable on the Seven (7) Shares of Stock, and Seven and 67/100 (\$4.67) Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of

Seven and 73/100 (\$10.73) Dollars, (\$7.00) Dollars, being the regular monthly payment on said stock and Three and 72/100 (\$3.72) Dollars, being the monthly interest on balance due); for the next twenty months the sum of

Nine and 80/100 (\$9.80) Dollars, (\$7.00) Dollars, being the regular monthly payment on said stock and Seven and 80/100 (\$2.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Eight and 87/100 (\$8.87) Dollars, (\$7.00) Dollars, being the monthly payment on said shares of stock and One and 87/100 (\$1.87) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of

Seven and 92/100 (\$7.92) Dollars, (\$7.00) Dollars, being the monthly payment on said shares of stock and Ninety Three and 93/100 (\$93.93) Cents, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Seven (7) shares of stock and the certificate thereof, the amount at such time paid shares by to be credited as a payment upon the advance or loan made, the said

Marie Williams and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against I the said Marie Williams in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Marie Williams in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Marie Williams

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In City of Greenville Beginning on right of way of C. & G. Railway thence N. 77° 8' W. 130 feet to Gledhill Street, thence with Gledhill Street S. 125° 6' 16" E. 160 feet to Nichols street to Railroad thence Northwesterly with Railroad right of way 206 1/4 feet to the beginning corner and being the same lot conveyed to me by J. W. Gray, Register, deed dated January 8th, 1913, and recorded in Deed Book 14 Page 1311 P. M. C. Office Greenville County.
