WHEREAS, *J. H. Hammond*, the said *J. H. Hammond* in and by *Myself* certain *Securities* note in writing, of even date with these presents, well and truly indebted to *Me (People's Bank of Mountain Summit Successors)*

in the full and just sum of *Three thousand Eighty Nine* Dollars, to be paid *\$1111 on Feb. 15, 1934, and \$2545.49 on November 1st, 1934.*

with interest thereon, from *maturity* at the rate of *Eight* per cent. per annum, to be computed and paid *semi-annually*
