I, Vernon Josiah Holloway, of Greenville, S.C. SEND GREETING:

WHEREAS, I, Vernon Josiah Holloway  
in and by my certain promissory note in writing, of  
even date with these presents, am well and truly indebted to

Farmers Loan and Trust Company  
in the full and just sum of One hundred sixty and no/100 (\$160.00)  
Dollars, to be paid one year after date

with interest thereon, from date the rate of 8 per cent. per annum, to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per centum besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage) as in and by the said note,  
reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, Vernon Josiah Holloway  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

Farmers Loan and Trust Company  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

Vernon Josiah Holloway  
in hand well and truly paid by the said

Farmers Loan and Trust Company  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do  
grant, bargain, sell and release unto the said Farmers Loan and Trust Company: All that certain piece, parcel

or lot of land situate, lying and being in the State of South Carolina, County of  
Greenville and in the City of Greenville, and on Sullivan Street, described by metes and  
bounds, as follows, to-wit:

Beginning on Sullivan Street, corner of J.C. Milford land, and running thence with  
Milford line N. 3-06 W. one hundred thirty-three feet; thence S. 89-15 E. fifty feet;  
thence N. 2-45 E. one hundred thirty four and 5/10 feet to Sullivan Street; thence with  
Sullivan Street N. 89-15 W. fifty feet to the beginning corner; this being the same lot  
of land heretofore conveyed to Vernon Josiah Holloway by deed of A.C. Davis, dated December  
4, 1920, and recorded in the R.M.C. Office for said County and State in Volume 67, at  
page 200
