until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Ten per cent. of the amount due* besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

Heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in *Gant Township*
Greenville County, State aforesaid,

About *10* miles from Greenville, S.C. and is a portion of land, deeded to Letty Davis by Richard Jacobs (Deed dated October - 1886) said Deed being recorded in the R.M.C. Office for Greenville County in vol. *A* at page *344* and has the following metes and bounds to-wit:

Beginning at a stake 3xom on P. B. McWhite's line and 13x0L of Lennuel Davis' tract and running thence with McWhite's lines S. 51-45 E. 30-88 Chs. to stone 3x of Richard Davis Tract; thence N. 40-30 E. 36-10 to sweet gum 3x; thence N. 83-15 W. 22-00 to Ella Curretton corner; thence N. 83-15 W. 6-53 to stone in field near house, thence S. 24-15 W. 2-55 to stone 3x thence N. 80 W. 10-18 to stone 3xom on Lennuel Davis line; thence with said Lennuel Davis line S. 24-15 W. 4-22, to the beginning corner bounded by lands by Letty Davis, Ella Curretton, Richard Davis et al and being the same tract of land conveyed by Letty Davis to Jannie Davis by deed dated Feb. 10th, 1914 and recorded in the R.M.C. Office for Greenville County in book *28* at page *300*.
