in the full and just sum of *one hundred fifty* Dollars, to be paid: *ninety (90) days after date.*

with interest thereon from *date paid in 1921* at the rate of *eight* per cent. per annum, to be computed and paid *quarterly in advance* until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Twenty Five (\$25.00) dollars*, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear

NOW KNOW ALL MEN, That the said Mortgagee, *J. T. Abercrombie*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagee, in hand well and truly paid by the said Mortgagee, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, and *its Successors* heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in *Dunklin Township* County, State aforesaid,

Containing *ninety-four and one-twenty-fifth (94-1/25)* acres, more or less, having the following *whites and bounds*:

Beginning at a stone near a bridge, thence running S. 32 1/2 W. 16.69 to a pine; thence S. 74 W. 2.50 to a stone on Dunklin Bridge Road; thence along said road 2.50 to a stone; thence crossing said road 3 1/2 E. 6.65 to a stump; thence N. 73 3/4 W. 14.74 to a stone; thence S. 12 E. 5.13 to a stone; thence N. 70 W. 5.00 to stone; thence N. 25 E. 15.77 to stone on *branch*; thence *up* the branch to the beginning corner, being tracts Nos. 1, 2 and 5, and the home tract of *William Sims*.
