And it is understood and agreed that this mortgage
 is executed and accepted upon the following conditions:

I that the Mortgagor shall insure his life for ^{the life of} ~~one~~
 other person for his benefit in some reputable Insurance
 Company doing business in the State of South Carolina
 in a sum not less than Ten Thousand (\$10,000.00)
 dollars, and shall keep the said Policy of Insurance
 in force during the period for which Said Note and
 Mortgage shall run, which said policy of Insurance
 shall be assigned to the Company herein as collateral
 security for the debt hereby secured, and in the event of
 the death of the said assured during the period for
 which said Note and Mortgage may run, it shall be
 the duty of the Company herein named, at the request
 of the holder of said Note and Mortgage, or of the
 Guarantor herein named, to declare all of said
 indebtedness due and payable immediately, to collect the
 amount due on the said Policy of Insurance and apply
 the proceeds to the payment of any of said indebtedness.
