All my undivided one-half interest in that certain lot, piece, parcel or tract of land
situate, lying and being in the State of South Carolina and County of Greenville in
Greenville Township, in the subdivision known as Kanatenah and known and designated as
Lot number five of Block "D" on the revised plat of the property aforesaid, to be
recorded in the R.M.C. Office of said County, reference to which is hereby made as a
part hereof.

The said lot of land has the following metes and bounds, to wit: Beginning at a stake
on the North side of Oregon Street, at the corner of lot number Four, and running thence
along said Oregon Street sixty feet to a stake at corner of lot number Six; thence along
said lot one hundred and sixty-five feet to a stake at the corner of Lot Number thirteen;
thence along said lot sixty feet to a stake at the corner of lot number Four; thence
along said lot last named one hundred sixty-five feet to the beginning point on Oregon
Street.
