Township, County and State aforesaid, at the Northwest corner of Aberdeen Avenue and Elsie Street, and being known and designated as Lot No. 12 on Plat No. 1 of Park Hill property as shown on plat recorded in Plat Book "F" at page 135 and having according to said plat the following metes and bounds, to-wit:-
Beginning at an iron pin, the northwest corner of Aberdeen Avenue and Elsie Street, and running thence with Elsie Street N. 62-50 W. 190 feet to stake in corner of lot No. 15; thence with line of that lot S. 27-10 W. 70 feet to stake, corner of lot No. 13; thence with line of that lot S. 62-50 E. 180 feet to stake on Aberdeen Avenue; thence with said Avenue N. 27-10 E. 70 feet to the point of beginning.
