WHEREAS, I, the said *Zadie Germany*, in and by my certain Presentments, note in writing, of even date with these presents, am well and truly indebted to *Zara Lucile Goodwin Schuyler* in the full and just sum of Eighteen Hundred and Seventy-five (\$1875.00) Dollars, to be paid at *Interest at 8% per annum* plus interest thereon, from *the date of this instrument* until paid in full; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *\$312.50* besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said *Zadie Germany*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Zara Lucile Goodwin Schuyler*, according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *Zadie Germany*, in hand well and truly paid by the said *Zara Lucile Goodwin Schuyler*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *Zara Lucile Goodwin Schuyler*:

All that certain piece, parcel or lot of land situate, lying and being in Ward one of the City of Greenville, County and State aforesaid, on the corner of Goodwin Street and Shumate Alley, and being designated as lot no. 6 as shown on plat according to Plat Book "A" page 149, and having the following metes and bounds, according to said plat, to-wit:

Beginning at the corner of lot no. 5 on Goodwin Street and running thence with Goodwin Street N. 69° 14' E. 51 feet 6 in. to corner of Shumate Alley; thence with Shumate Alley S. 17° E. 95 feet 3 in. to corner; thence S. 70° W. 45 feet, 6 in. to corner of lot no. 5; thence with line of lot no. 5, N. 19° 33' W. 94 feet, 3 in. to the beginning corner, being the same lot of land conveyed to me by *Zara Lucile Goodwin Schuyler*, by deed of even date herewith, the same not yet recorded and this mortgage is given to secure a portion of the purchase price therefore.
