do hereby bind myself, my Heirs, Executors and Administrators.

to warrant and forever defend, all and singular, the said premises unto the said C. L. Putman his Heirs and Assigns, from and against me and my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
