WHEREAS, I, *Helen M. Lindsay*, the said *Helen M. Lindsay*
in and by *One* certain *Premissary* note in writing, of
even date with these presents, *am* well and truly indebted to

W. R. Timmons
in the full and just sum of *One Thousand eight hundred (\$1800.00) and no/100*
Dollars, to be paid *On or before one year from date*

with interest thereon, from *Date of satisfaction* at the rate of *8* per cent. per annum, to be
computed and paid *Semi-annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,
reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said *W. R. Timmons*

All of that certain piece, parcel, tract or lot of land lying, situate and being in the
State and County aforesaid and in Greenville Township and being Lot number sixty-four (64)
according to survey and plat of Overbrook Land Company by H. Olin Jones, September 17, 1913
and of record in the office of R.M.C. for Greenville County, the above mentioned lot being
more fully described as follows, to-wit:

Beginning at a point the joint corner of lots #63 and #64 on Overbrook Circle, and running
thence S. 12-38 W. 50.8 feet; thence S. 11-37 E. 50 feet; thence S. 24-20 E. 50 feet; thence
S. 42-33 E. 49.9 feet; thence S. 58-03 E. 56.1 feet to a point, joint corner of lots #64
