WHEREAS, I, the said J. J. Miller
in and by my certain promissory note in writing, of
even date with these presents, am well and truly indebted to

in the full and just sum of Six hundred dollars (\$600.00)
Dollars, to be paid on or before one year after date

with interest thereon, from date at the rate of 8 per cent. per annum, to be
computed and paid annually in advance
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent (10%) besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I the said J. J. Miller
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said J. W. Norwood
according to the terms of said note, and also in consideration of the further sum of Three Dollars, to me the said J. J. Miller
in hand well and truly paid by the said J. W. Norwood

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said J. W. Norwood, his heirs and assigns

all that piece, parcel or lot of land in Greenville Town-
ship Greenville County State of South Carolina in the
City of Greenville having the following metes and bounds:
Beginning at the corner of Daveyarts lot a part 153
feet from south side of East Washington Street on East
side of Church Street running thence Southwesterly with
Church Street about 64 1/2 feet to corner of Eugene Means
lot which corner is about 132 1/2 feet from M^c Bee
Avenue thence along the line of Means and Norwood's
lots about parallel with M^c Bee Avenue southeasterly
about 179 feet thence along the line of Witherpoons lot
about parallel with Church Street northeasterly 63 feet
more or less to Carpenters lot thence along the line
of Carpenters Woodside's and Daveyarts Northwesterly
184 feet to the beginning.

This is the same lot conveyed to me by J. O. Allen
by deed dated October 15, 1909 and recorded in the
R. M. C. Office for Greenville County in Book 53 of
