interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Ten per cent*

besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney in legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,

that certain piece, parcel or lot of land situate,  
lying and being in the County and State aforesaid,  
and having the following Metes and bounds  
to-wit:*

*beginning at a stake 3X on Greene ave. and running  
thence S. 69 E. 100' 6" to a stake 3X; thence N. 31 E.  
50 feet to a stake 3X; thence N. 65 W. 49' 4" to stake  
3X on Greene ave. thence with Greene ave.  
S. 29 W. 57 feet to the beginning corner*
