in the full and just sum of Twenty Three Hundred + 00/100 (\$2,300.00)

to be paid on or before the date when the 45th series of the Capital Stock of the said GREENVILLE
BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or be-
fore Saturday night of each and every week until paid in full; and if I fail to pay said interest or

is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE
BUILDING AND LOAN ASSOCIATION.

All that certain piece, parcel or lot of land situated, lying and being in Ward one of the city of Greenville, State of South Carolina, on the north side of Narvelly Street and being known and designated as lot #7, as shown on Plat of Agnewingham & Judan's property, recorded in Plat Book "E", at Page 214 and being more particularly described as follows, to wit:
