in the full and just sum of one thousand \$1,000.00

to be paid on or before the date when the 50th series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

Mandy, in hand well and truly paid by the said GREENVILLE BUILDING AND LOAN ASSOCIATION at and before the signing of these presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said GREENVILLE BUILDING AND LOAN ASSOCIATION

all that piece parcel or lot of land situate, lying and being on the east side of Sumner Street, in the City of Greenville State and County aforesaid, designated as lot no. 6 in Block "A" on a plat recorded in plat book "A", page 99, R. M. C. Office for Greenville County, and having, according to a survey made by Lockwood, Green & Company, dated May 1905, the following lines, courses and distances to-wit:-
Beginning at a stake on Sumner Street, corner of lot no. 7; thence with Sumner Street, N. 16-20 E. 52.375 feet to a stake, corner of lot no. 5; thence with line of lot no. 5, S. 75-30 E. 193.93 feet to stake on 20 foot alley; thence with said 20 foot alley, S. 17-00 W. 51.17 feet to stake, corner of lot no. 7; thence with line of lot no. 7, N. 75-30 W. 193.47 feet to the beginning corner.
