Three thousand five hundred (\$3,500.00)

DOLLARS,

to be paid on or before the date when the 2nd Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable
