SEND GREETING:

WHEREAS, *I*, the said *P. D. Woods*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of

Eighteen hundred (\$1800.00)

DOLLARS,

to be paid on or before the date when the *15th* Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable

Rf Saxon line; thence with said line S. 29° W. 50 feet to iron pin by tree; thence S. 62° E. 88 feet to an iron pin on Green Avenue; thence with Northwest side of Green Avenue N. 29° E. 50 feet to the beginning corner.
