SEND GREETING:

WHEREAS, *I*, the said *S. M. Patrick*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Five thousand (\$5000.00)*

DOLLARS,

to be paid on or before the date when the *16-a* Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable

and also in consideration of the further sum of Three Dollars, to *me* the said mortgagor in hand well and truly paid by the said THE PEOPLES BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell, and release unto the said THE PEOPLES BUILDING AND LOAN ASSOCIATION, its successors and assigns, all that certain piece, parcel and lot of land lying, being and situate in Greenville County, in the State of South Carolina, as follows, to-wit:

Beginning at a stake on the Southside of Mountain View Avenue, 500 feet West of the intersection of Townes Street Extension, running thence along Mountain View Avenue, N. 79.45 W. 50 feet to a stake; thence S. 10.15 W. 170 1/2 feet to an alley; thence with said alley, S. 79.00 E. 50 feet to a stake; thence N. 10.15 E. 170 1/2 feet to the corner of beginning on Mountain View Avenue.
