WHEREAS, I

DOLLARS,

to be paid on or before the date when the 31<sup>st</sup> Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable
