with interest thereon, from *date* at the rate of *8* per cent. per annum, to be  
computed and paid *1/1/11* until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note..... to become immediately due at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *other per cent.*

..... besides all costs and expenses of collection, to be  
added to the amount due on said note..... to be collectible as part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note.....

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,  
bargain, sell and release unto the said *W. H. Webb*

All my right, title and interest, the same being an  
undivided one half interest in and to all that  
certain lot of land situated in Ward Three of the  
City of Greenville, at the corner of West Washington  
and Westfield streets, and being more particularly  
described as follows:

Beginning at a point corner of Washington and  
Westfield sts. and running thence with Washington  
street 91 feet to line of lot now or formerly owned  
by B. D. King; thence with line of said King lot,  
20 1/2 feet to a stake; thence parallel with Washington  
street, 91 feet to a point on Westfield street;  
thence with said Westfield street 21 1/2 feet to  
the beginning corner.
