SEND GREETING:

WHEREAS, *R. P. Deeney*, the said,

R. P. Deeney

in and by *R. P. Deeney* certain note in writing, of

even date with these presents, *Dec. 1, 1921* well and truly indebted to

Johans P. Hellawell
in the full and just sum of *Five Thousand Six Hundred and no 00 Dollars (\$5600.00)*
Dollars, to be paid *Johans P. Hellawell* on the 1st day of December 1921

with interest thereon, from *Date* at the rate of *8* per cent. per annum, to be
computed and paid *quarterly*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *10% of the sum due*

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note
reference being thereunto had, as will more fully appear *in the body of the instrument*.

NOW, KNOW ALL MEN, That *R. P. Deeney*, the said, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said,

according to the terms of said note, *also in consideration of the further sum of Three Dollars, to be paid*, the said,

in hand well and truly paid by the said *Johans P. Hellawell*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,
bargain, sell and release unto the said *Johans P. Hellawell*, his heirs and executors

all that certain piece of land situate
lying and being in the city of Greenville, County
and State of South Carolina, on the north side of Crescent
Avenue and having 100 feet frontage on the north side
of Crescent Avenue 100 feet deep at the intersection of
Crescent Avenue and Jones Avenue and running thence
with said Crescent Avenue N. 84-20 E. 90 feet to an
iron pin, corner of lot of J. L. Williams; thence with
line of said lot N. 1-30 W. 200 feet to an iron pin,
thence S. 84-20 W. 90 feet to an iron pin, corner of
lot of W. C. McDaniel; thence with line of said lot
N. 1-30 W. 200 feet to the beginning corner. Said lot
contains a two story house and garage and is
now known as 403 Crescent Avenue.
