*That I, W. G. Humphreys of Greenville County, South Carolina,* SEND GREETING:

WHEREAS, I, the said *W. G. Humphreys*, in and by my certain promises, even date with these presents, am well and truly indebted to

*H. K. Jones, Attorney*, in the full and just sum of Three Thousand + 20/100 (\$3000.00) Dollars, to be paid Ninety (90) days after date

with interest thereon, from *dated 1916* at the rate of *Eight* per cent. per annum, to be computed and paid *quarterly*

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose the mortgage; said note further providing for an attorney's fee of *less per cent (10%)*

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereunto had, as will more fully appear.

*assignees, All that certain lot of land in the City of Greenville, County of Greenville, said State, on East Washington Street, beginning on East Washington Street, at Dr. Weeden's corner, thence 2.19 W. 180 feet to the Red Bayee line, thence N. 71 W. 46 feet, thence N. 19 E. 177 feet to a ten foot alley, thence along the center of said alley N. 19 E. 103 feet to Washington Street, thence with Washington Street 4.73 E. 46 feet to the beginning corner being the same lot surveyed to me by John L.
