TO ALL WHOM THESE PRESENTS MAY CONCERN:

That *A. Charlotte Tripp Walter*, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *A*, the said *Charlotte Tripp Walter*, in and by *my* certain note or obligation, bearing the *22nd* day of *August* 192*5*

*A am* indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *Seven Hundred (\$700.00)* Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the *22nd* day of *August* A. D. 192*5*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

*A* the said *Charlotte Tripp Walter* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *September* 192*5*, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *\$11.67*

NOW, KNOW ALL MEN, That *A* the said *Charlotte Tripp Walter*, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me* the said *Charlotte Tripp Walter*.

In subdivision of Gridley and Bailey lands, near Verner Springs, and being known and designated as Lot No. 294, according to plat of said property recorded in R.M.C. Office for Greenville County in Plat Book A, at page 278, said lot has a frontage on McCary Street of sixty-six (66) feet and a depth of one hundred fifty-six (156) feet on east side and one hundred sixty-six (166) feet on west side and a width of 66.82 feet in the rear, and is the same lot conveyed to me by Mary Keenan Smith by deed dated July 25th, 1925 and recorded in deed book 83, page 443, R.M.C. Office for Greenville County.
