with interest thereon from date at the rate of 8 per cent. per annum, to be computed and paid Annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

all that certain lot, piece, parcel or tract of land situate lying and being in the State of South Carolina and County of Greenville in Greenville Township at or near the corporate limits of the city of Greenville known and designated as lot no. 1 on a plat of Mrs. H. B. Wilkins' property made by R. E. Dalton, dated March, 1924, and recorded in the R. M. C. Office for said County and State in Plat Book "5" at page 209, and having according to said plat, the following metes and bounds: Beginning at an iron pipe on the northeast corner of Elm and Otis Streets, and running thence along Otis Street N. 72 - E. 170 ft. to an iron pipe on the corner of land of Mrs. H. B. Wilkins, thence along her line N. 18 W. 63 Ft. to an iron pipe on the northeast corner of lot no. 2; thence with line of last mentioned lot S. 72 W. 170 feet to an iron pipe on the east side of Elm St. thence along Elm St. S. 18 E. 63 feet to the beginning corner.
