for the following material etc. used in improvement on
 lot hereinafter described

with interest thereon, from *Maturity* at the rate of 8 per cent. per annum, to be
 computed and paid *July 10th, 1925*

upon paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
 interest be at any time past due, and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,
 who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent.*

July 10th, 1924 besides all costs and expenses of collection, to be
 added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
 any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,
 bargain, sell and release unto the said *Morgan-Cüstis Company*

All that piece or lot of land in Greenville City
 and County of Greenville, State aforesaid being part of
 lot 1201 of Block 11 of the Bayce Addition and having
 the following metes and bounds to-wit:

Beginning at an iron pin on the south side of
 East North Street 49 feet 2 inches from corner of
 East North Street and Carolina Avenue at the corner
 of lot of John W. Bantil thence running along the
 line of said lot of John W. Bantil N. 15° 0' E. 10.6 feet
 one inch to a point on a ten foot alley thence
 along said alley N. 76° 45' W. 49 feet 2 inches or more
 to an iron pin on Carolina Avenue thence along
 line of Carolina Avenue N. 15° 0' W. 12.6 feet one inch
