bargain, sell and release unto the said J.A. Campbell, All that certain piece, parcel or lot of land
situate, lying and being in the State and County aforesaid in Highland Township and having the
following metes and bounds, to-wit:- Beginning on a stone on the Tugaloo Road being the corner
of A.L. Campbell and J.S. Crain; thence nearly west with J.L. Crain line to stone; thence
South to stone; thence East to Stone corner of School land; thence northwest with School land
to stone on road leading to A.L. Campbell Res. thence nearly northeast with school land to
stone on the South side to the Tugaloo road; thence northwest to stone beginning corner, and
containing Ten Acres, more or less. And being the same land conveyed to me by A.L. Campbell by
deed dated Jan. 5th, 1917.
Also all that piece, parcel or lot of land situate, lying and being in the State and County
aforesaid in Highland Township and having the following metes and bounds to-wit:- Beginning on
a stone the corner of A.L. Campbell; thence nearly North to stone; thence nearly Southwest to
