

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

And we do hereby bind ourselves, our successors in office, the said Association, its heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Mrs. Una Lee Hendrick, her heirs and assigns, from and against ourselves, our successors heirs, executors, administrators and assigns and every person whomsoever lawfully claiming or to claim the same or any part thereof.
