

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I Harry Mosely of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Harry Mosely in and by my certain note or obligation, bearing the Twenty-seventh day of January 1925 am I indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Six hundred (\$600.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 20th day of February A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I the said Harry Mosely shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of February 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Ten (\$10.00) Dollars, being the regular monthly installment payable on the Six (6) Shares of Stock, and Four (\$4.00) Dollars, being the monthly interest, on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Nine and 6/100 (\$9.60) Dollars, (Six (\$6.00) Dollars, being the regular monthly payment on said stock, and 3/100 (\$0.30) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Eight and 4/100 (\$8.40) Dollars, (Five (\$5.00) Dollars, being the regular monthly payment on said stock and 3/100 (\$0.30) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Six and 8/100 (\$6.80) Dollars, (Three (\$3.00) Dollars, being the monthly payment on said shares of stock and 3/100 (\$0.30) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Six and 8/100 (\$6.80) Dollars, (Three (\$3.00) Dollars, being the monthly payment on said shares of stock and 3/100 (\$0.30) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said six shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said Harry Mosely and shall pay or cause to be paid all fines which may be daily imposed upon or charged against me the said Harry Mosely in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto here will more fully appear.

NOW, KNOW ALL MEN, That I, the said Harry Mosely in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Harry Mosely in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot in city of Greenville Greenville County, State of South Carolina fronting north side of Jenkins street eight seven (87) feet with a depth of approximately two hundred (200) feet and being same lot whereon I now reside, conveyed to me by A.C. Davis, deed dated November 23, 1918 recorded in Vol. 44, page 316, P. M. C. office for Greenville County, S. C.
