That J. R. Pearson

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, the said J. R. Pearson, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of \$4,000.00 Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, on the 20th or before the end of the month of February, A. D. 1922, according to the provisions of the Charter, By-Laws, Rules and Regulations of the Company, manner and form following, that is to say, that I, the said J. R. Pearson, shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville, South Carolina, monthly, on the 20th or before the end of the month of February, 1922, and on the 20th or before the end of each month thereafter, for twenty successive months, the sum of Sixty Seven Dollars (\$6.67) Dollars, being the regular monthly installment payable on said stock, and Two & 67/100 (\$2.67) Dollars, being the monthly interest on balance due; for the next twenty months the sum of Fourty Six Dollars (\$4.60) Dollars, being the monthly payment on said shares of stock and One & 67/100 (\$1.67) Dollars, being the monthly interest on balance due; for the next twenty months pay the sum of Four & 53/100 (\$4.53) Dollars, being the monthly payment on said shares of stock and Fifty-Three (0.53) cents Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said shares of stock and the certificate thereof, the amount at such time paid shares by to be credited as a payment upon the advance or loan made, the said J.
