

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Belle Tollison of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Belle Tollison in and by my certain note or obligation, bearing the 10th day of March 1925 indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Three Hundred + 20/100 (\$300.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 10th day of March A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Belle Tollison shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City address, monthly, on the 20th or before the end of the month of March 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Three + 20/100 (\$3.00) Dollars, being the regular monthly installment payable on the Three (3) Shares of Stock, and Two + 100/100 (\$2.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Four + 00/100 (\$4.00) Dollars, being the regular monthly payment on said stock, and One + 00/100 (\$1.00) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Four + 20/100 (\$4.20) Dollars, being the regular monthly payment on said stock and One + 20/100 (\$1.20) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three + 80/100 (\$3.80) Dollars, being the regular monthly payment on said stock and One + 80/100 (\$1.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three + 40/100 (\$3.40) Dollars, being the regular monthly payment on said stock and One + 40/100 (\$1.40) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three + 00/100 (\$3.00) Dollars, being the regular monthly payment on said stock and One + 00/100 (\$1.00) Dollars, being the monthly interest on balance due);

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said (3) shares of stock and the certificate thereof, the amount at such time paid shares by to be credited as a payment upon the advance or loan made, the said Belle Tollison

and shall pay or cause to be paid all fines which may be duly imposed upon or charged against the said Belle Tollison in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunto written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Belle Tollison in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to the said Belle Tollison in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Known and designated as Lot No. eight (8) on plat made by W.D. Neves of Hoke Subdivision said plat recorded in Plat Book "C", page 54, R.M.C. Office for Greenville County. Said lot fronting South side of Gentry Street fifty (50) feet, more or less, and has a depth of one hundred fifty (150) feet, more or less, and is one of the lots conveyed to me by T.A. Honour by deed dated August 15th, 1923 and recorded in Volume 97, page 553, R.M.C. Office for Greenville County.

State of South Carolina, County of Greenville. For value received, I, F.W. Brown do hereby release unto Belle Tollison, her heirs and assigns, the lien of the mortgage executed by her to me dated November 15th, 1923, recorded in Volume 110, page 244, R.M.C.
