

# THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, Fred C. Glasco, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Fred C. Glasco, in and by my certain note or obligation, bearing the 22<sup>nd</sup> day of May 1925, duly incorporated under the laws of such State), in the sum of Twenty-four Hundred & no/100 (\$2400) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 22<sup>nd</sup> day of May A. D. 1925, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Fred C. Glasco shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of June 1925, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Forty & no/100 (\$40.00) Dollars, (24.00) Dollars,

being the regular monthly installment payable on the Twenty-four Shares of Stock, and Fifteen & no/100 (\$16.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Thirty-six & no/100 (\$36.80) Dollars, (24.00) Dollars, being the regular monthly payment on said stock, and Twelve & no/100 (\$12.80) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Thirty-three & no/100 (\$33.60) Dollars, (24.00) Dollars, being the regular monthly payment on said stock and Nine & no/100 (\$9.60) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Thirty & no/100 (\$30.40) Dollars, (24.00) Dollars, being the regular monthly payment on said shares of stock and Four & no/100 (\$4.40) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-seven & no/100 (\$27.20) Dollars, (24.00) Dollars, being the regular monthly payment on said shares of stock and Three & no/100 (\$3.20) Dollars, being the monthly interest on balance due.)

Each of the payments on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said Twenty-four Shares of stock, and the condition that the amount at such time paid shall be credited as a payment upon the advance or loan made, the said and shall pay or cause to be paid, all taxes, which may be duly imposed upon or charged against I the said Fred C. Glasco, in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Fred C. Glasco, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In Greenville Township, lot 14 on plat recorded in plat No. 114 in the office of the County of Greenville, beginning on East 32-20 N. 45 feet with Street to corner of lot 15, thence S. 58-27 E. 125.9 feet to corner of lot 15, thence N. 32-30 E. 186 feet to corner of lot 15, thence N. 58-27 W. 186 feet to corner of lot 15, and being the same lot conveyed to me by J. J. Groves by deed dated July 15<sup>th</sup> 1924, in consideration of the sum of \$323.67 covering cash and recorded interest, signed of bonds of Home Owners' Loan Corporation of the face value of \$1323.67, partly acknowledged, the undersigned, being the owner and holder of the mortgage, with interest on principal from December 1<sup>st</sup> 1934 at 8% of the sum of the mortgage securing the same forever discharged and released.
