All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, bounded two of the City of Greenville, on the north side of Earle Street and being the northwest corner of Earle and Bennett Streets and being known and designated as Lot No. 18 of Section "4" of a plat of Stone Land Company, said plat recorded in Plat Book "A", p. 337-345 and having the following metes and bounds, to wit;

Beginning at a stake on the north-west corner of Earle and Bennett Streets and running thence with Bennett Street, N. 18-30.
