in the full and just sum of five hundred (\$500.00) dollars  
Dollars, to be paid one year after date

with interest thereon, from stated at the rate of 8 per cent. per annum, to be  
computed and paid Semi-Monthly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof,  
who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10 per cent

besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, refer-  
ence being thereunto had, as will more fully appear)

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to me the said  
W.M. Patton in hand well and truly paid by the said W.E. McCain

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant,  
bargain, sell and release unto the said W.E. McCain all that certain piece,

payable lot of land situated, lying and being  
in Greenville Township Greenville County State  
of South Carolina, on the west side of Hudson  
Street in the city of Greenville and being more  
particularly described as follows according to a  
plat thereof prepared by C.M. Farnham, Jr. Engineer  
on Dec. 7th, 1925.

Beginning at an iron pin on the west side of  
Hudson Street at a point where it intersects the  
south bank of the old bed or run of Kedy River  
and running thence with said old run N. 34-30  
W. 54.8 feet to an iron pin; thence across said old  
run N. 37-30 E. 125.5 feet more or less to an iron pin  
in the center of the end of Gibbs street, thence with  
the center of said street as the line S. 44-35 E. 445.2  
feet more or less to an iron pin in the west line  
of Hudson Street thence with the line of said last
