TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, the said *C. M. Gason, Jr.*,  
in and by my certain Promissory Note of even date with these presents,  
well and truly indebted to *W. H. Gardner*,  
in the full and just sum of *Three Thousand \$3,000.00 Dollars*,  
Dollars, to be paid one year after date,  
with interest thereon, from *date* at the rate of *7* per cent. per annum, to be  
computed and paid *semi annually*,  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Five per cent.*  
besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same to be placed in the hands of an attorney for collection, or of said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note reference being thereto had, as will more fully appear.

NOW, KNOW ALL MEN, That the said *C. M. Gason, Jr.*,  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *W. H. Gardner*,  
according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *C. M. Gason, Jr.*,  
in hand well and truly paid by the said *W. H. Gardner*.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents, do grant, bargain, sell and release unto the said *W. H. Gardner*,

*All that piece, parcel or lot of land, situated in Greenville Townships, Greenville County, State of South Carolina, being known and called "Block A" in lot No 7, Block "A" on a plat of "Main Street Addition" in Greenville County, said plat recorded in the R. M. C. Office for Greenville County in Plat book "B" page 396-397 and having the following metes and bounds to wit:*

"Beginning at a point on the West side of Bunccombe Road at joint corner of lots Nos. 7 and 8 and running thence in a westerly direction 167 feet to a point on a ten foot Alley, joint corner of lots Nos 7 and 8; thence in a southerly direction along said Alley 50 feet to a point joint corner of lots Nos 7 and 6; thence in a easterly direction along line of lot No 6 188 feet to a point on Bunccombe Road thence along said Bunccombe Road in a northerly direction 50 feet to the beginning point being the same lot of land conveyed to me by F. R. L. Baldwin by Deed dated Sept. 6th, 1925, and recorded in the R. M. C. Office for Greenville County in lot 73, page 470."
