at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Ora L. Finley, all that piece, parcel

and tract of land in the County of Greenville, State of South Carolina, near Marietta and being known and designated as tract no. 1 according to Survey made by H. A. Hester November 29, 1921 and being a part of the John Guest Estate and containing 72-1/4 acres and more particularly described as follows;

Beginning at a stone 70 ft. on Saluda River at the corner of tract no. 3 and running thence N. 10° 21' S. 80 to Hickory X m. thence N. 8° 1-1/2 W. 10.68 to pine 21 m; thence N. 17° 21' 165.30 to iron pin; thence N. 45° 21' 8.00 to iron pin; thence N. 10° 1/4 W. 117.67 to iron pin 21 m on the line of Eddie Guest-Laird; thence N. 65° 1/4 W. 18.70 to stone 21 m to corner of tract no. 2; thence along the line of tract no. 2 S. 41° 21' 22.80 to stone at mouth of branch 21 m; thence along the meanders of said branch as a line 24° 22' to stone 21 m; thence S. 28° 5-1/4 E. 6.00 to iron pin; thence S. 66° 1/4 E. 7.60 to cedar stump 21 m; thence S. 69° 1/2 E. 10.60 to stone 21 m; thence S. 1/2 E. 9.00 to stone 21 m; on Saluda River; thence along said river 64 ft. to the beginning and being bounded by Saluda River, laid off Eddie Guest, R. Eppes and tracts nos. 2 and 3 as shown on Hester plat above referred to. Also;

All that piece, parcel or tract of land situate lying land being in the County of Greenville, State of South Carolina, near Marietta,

Beginning at a stone 21 m; and running thence N. 30° 21' S. 80 to a small poplar, corner of John E. Guest land, thence S. 69° 1/2 W. 16.50 to stake; thence S. 32° S. 12.67 to stone 21 m; thence in a northeasterly direction to the beginning corner and containing 19 acres as per plat of H. A. Hester dated January 26, 1919 being known as Landry Gibbons or Mcbee land and being a part of Estate of John Guest, deceased,
