WHEREAS, I....., the said..... A.W. Reynolds

with interest thereon from..... date..... semi-annually..... at the rate of..... seven..... per cent. per annum, to be
 computed and paid.....

..... in principal in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at
 any time due and unpaid, then the whole amount evidenced by said note..... to become immediately due, at the option of the holder hereof, who may sue thereon
 and recover this mortgage; and in case said note....., after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity
 should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note..... or this mortgage in the
 hands of an attorney for legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10.....
 per cent. the indebtedness, as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
 bargain, sell and release unto the said..... W.W. Griffin, All that certain piece, parcel or lot of land

situate near the City of Greenville, on the East side of Jones Avenue, being a portion of
 lots designated as 7, 8 and 9 of the W.C. McDaniel property, plat of which is recorded in the
 R.M.C. Office for Greenville County, in Plat Book "F", at page 186, and having the following
 metes and bounds, to wit: Beginning at an iron pin on the East side of Jones Avenue, said
 pin being 260 feet North of the Northeast corner of Jones Avenue and Camille Street, and
 running thence along the East side of Jones Avenue N. 1-00 E. 100 feet to an iron pin, which
 pin is 10 feet North of the joint line of lots 7 and 8 on said plat; thence S. 89-00 E. 232.7
 feet, more or less, to an iron pin in line of lot 30; thence along the joint line of lots 30
 7, 8 and 9, S. 5-08 W. 100.2 feet to an iron pin; thence N. 89-00 W. 225 feet, more or less,
 to the point of beginning on Jones Avenue, being the same property conveyed to me by the
 said W.W. Griffin by deed of even date herewith.

This mortgage is given to secure a portion of the purchase price of the above described
 property.

It is understood and agreed between the parties hereto that in the event that the above
 described property is divided into two lots, each fronting fifty feet on the East side of
 Jones Avenue, upon the payment by the mortgagor of the sum of twelve hundred fifty
 (\$1,250.00) Dollars, the mortgagee will release either of said fifty foot lots from the lien
 of this mortgage.

For value received, I, W.W. Griffin, the owner and
 holder of the within mortgage, do hereby release and
 forever discharge from the lien of said mortgage that
 portion of the within described premises in which
 the said A.W. Reynolds, conveyed a two-thirds undivided
 interest to Charles League and W.R. Hale, Jr., by deed
 dated July 20th, 1928; said lot hereby released has a
 frontage on Jones Avenue of fifty feet and an
 approximate depth of two hundred and twenty-
 five feet.
