until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note shall become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to do so, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the Augusta Road School Site on Argonne Drive, and being known and designated as Lot No. 26 of the C. D. Martin subdivision, as shown on plat of record in Plat Book 7, page 102, and having, according to said plat, the following streets and bounds, to wit:-

Beginning at an iron pin at the intersection of Argonne Drive and Tennessee Avenue, and running thence with Tennessee Avenue, N. 48-50 W. 180 feet to an iron pin, thence S. 41-48 E. 71 feet to an iron pin, thence N. 48-50 E. 180 feet to an iron pin on the West side of Argonne Drive, thence with said Argonne Drive, N. 41-10 W. 71 feet to the beginning corner, being the same lot of land conveyed to me by John R.
